Conditions of Entry

1. These Conditions of Entry must be read together with the Schedule. By entering, entrants agree that they have read and accept these conditions.
2. Entry is open to residents of the Applicable State who comply with the Entry Requirements (if any). Entries submitted by Ineligible Entrants are not accepted.
3. The Promotion will be run during the Promotion Period.
4. The Prize is not transferable or exchangeable and cannot be redeemed for cash. No alternative prize or cash alternatives will be offered. The dates are fixed in line with the 2024 Sydney Swans fixture (March – September 2024) so cannot be changed.
