



**HSBC SYDNEY SEVENS 2020**  
**HSBC Hot Seat – Pre-Event Social Competition**  
**Terms and conditions**

**Conditions of Entry:**

1. Information on how to enter and prizes forms part of these conditions. Entry into this competition for the Prize (the "**Promotion**") is deemed acceptance of these terms and conditions.
2. The Promotion commences at 09:00 AEST on Friday 17<sup>th</sup> January 2020 and closes at 11:00 AEST on Tuesday 21<sup>st</sup> January 2020 ("Promotion Period"). 12. If any prize is declined, or the winner cannot be contacted by 12:00 AEST Monday 27 January 2020, replacement winners may be selected at the Promoter's sole discretion in a manner consistent with these terms and conditions.
